Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.

Nonaffiliates	<i>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</i> <ul style="list-style-type: none"> ■ Gibraltar Mortgage Services, LLC, d/b/a The Gibraltar Group Mortgage (NMLS #1249915) does not share with nonaffiliates to market to you.
Joint marketing	<i>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</i> <ul style="list-style-type: none"> ■ Gibraltar Mortgage Services, LLC, d/b/a The Gibraltar Group Mortgage (NMLS #1249915) does not jointly market.
